The Grower Group Alliance (GGA) has announced the appointment of Tom Davidson to the role of Director of the South-West WA Drought Resilience Adoption and Innovation Hub (SW WA Hub).

### **Future Drought Fund (FDF) Drought Resilience Leaders Program**

Those committed to strengthening the future of their region are invited to participate in the FDF Drought Resilience Leaders Program. ### **Drought resilience tool – your chance to provide input**

Cropping farms in Western Australia are predicted to be more heavily impacted by a changing

climate than other regions, and adaptation is vital. To help farmers assess their risks and make plans, the Drought Resilience Self-Assessment Tool (DR SAT) is being developed. A prototype is now available, and producer feedback will be used to fine tune the tool ahead of a pilot later this year.
